b1 [REDACTED] telephoned Liaison 10-21-69 and made reference to a series of murders committed over recent weeks by an unknown assailant who has been labeled by the Press as the "Zodiac Killer." He further mentioned that following such murders, anagrams have been sent to the Press, it is assumed by the unknown subject. Recently, the "San Francisco Chronicle" published an unsolved portion of an anagram described by [REDACTED] as the last line of such anagram.

b1 [REDACTED]

b1 [REDACTED] explained that from the newspaper article it would appear that the remainder of the anagram had been solved.

The above information was telephonically furnished our San Francisco Office at 1:30 p.m., 10-21-69. Supervisor [REDACTED] advised that he would pass this information on to the San Francisco Police Department and the Napa County Sheriff's Office without disclosing [REDACTED] as the source of this information.

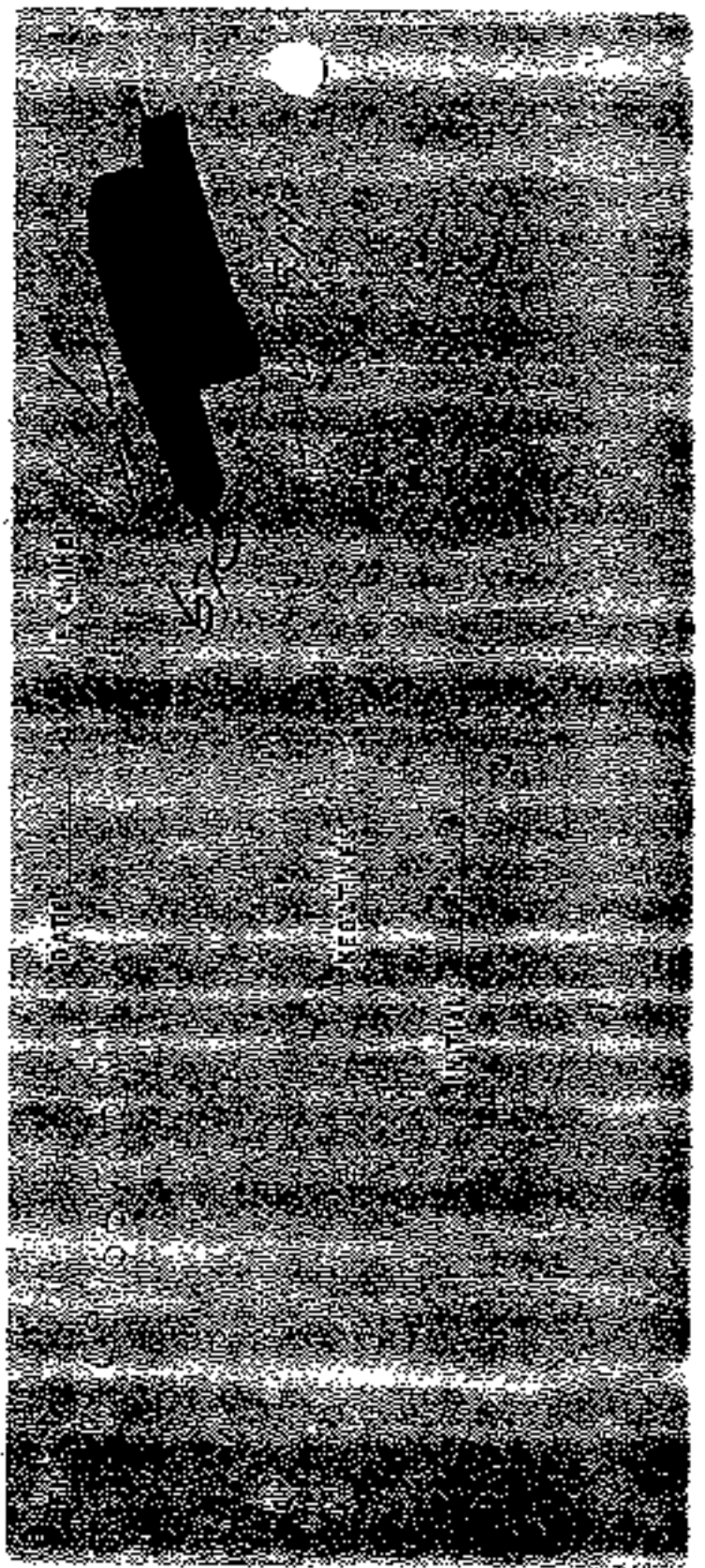

The attached concerns the much publicized so-called "Zodiac" killer who has murdered five persons and critically wounded two others who survived his assaults in the State of California between December 1968 and October 1969. An individual identifying himself as the "Zodiac" killer has been regularly corresponding with a newspaper in California. He has been commenting on the various murders attributed to the "Zodiac" killer furnishing such details which lend credence to his statements and for this reason the local police are confident that the correspondent is in fact the killer. This correspondent among other things has submitted a number of cryptograms with his letters which may possibly contain some evidence to his identity. The Cryptoanalysis Section at the Bureau is currently attempting to decipher some of these cryptograms even though no Federal jurisdiction has been established as yet. Retel describes [REDACTED]

b7c [REDACTED] who has also been attempting to decipher the "Zodiac's" cryptograms.
